

COMPENSATION DISCLOSURE POLICY

MATERIAL CONNECTION

Unless otherwise expressly stated, you should assume that all references to products and services on naturespresence.net are made because material connections exist between the website's owner ("Owner") and the providers of the mentioned products and services ("Provider").

GOOD FAITH RECOMMENDATIONS
